1. DEFINITION

定义

Capitalized terms used but not defined herein shall have the meanings ascribed to such terms in the Client Agreement.

TICK VALUE

基点

The “Tick” is the minimum amount that the price or value of an instrument may fluctuate pursuant to the market rules of the relevant regulated market. As profit and loss is converted into the account currency, a “Tick Value” is associated with each product and automatically converted to the clients’ accounts currency. For example, if the trading account is denominated in USD, then profit and loss will be calculated in USD. If a client traded in the UK100, which is priced in GBP, PRIMETIME GLOBAL MARKETS PTY LTD will automatically convert profit and loss into USD. The Tick Value details conversion rate in this example, would be the GBP/USD exchange rate.

「基点」是根据相关监管市场的市场规则下，工具的价格或价值的最小波幅。当利润与亏损转换为账户货币时，每种产品将会自动与「基点」连结，并自动转换为客户的账户货币。例如，如果交易账户以美元计价，那么利润与亏损将以美元计算。如果客户使用以英镑定价的UK100进行交易，那么本公司便会将利润与亏损自动转换为美元。在此示例中，详细「基点」转换率将是GBP / USD的汇率。

MINIMUM AND MAXIMUM TICKET SIZE

最小和最大订单

The minimum and maximum order size is the smallest and/or highest increment accepted and applicable to all order types. The indicative minimum and maximum trading sizes for each instrument are included in this product specification list below.

TRADING STEPS

交易步骤

“Trading Steps” relates to the minimum order size increment accepted and applicable to all order types. For example, if a client trades in UK100 and orders a ticket size of 0.1, 0.2, and 0.3 lots will be executed by KOHLE CAPITAL MARKETS LIMITED, but an order with a ticket size of 0.11 lots will not be executed in as much as the minimum allowed ticket size for UK100 is 0.1. Therefore, clients are only able to trade in the minimum ticket size or multiples thereof. The minimum and maximum trading steps for each instrument are included in the product specification list out in below pages.

“交易步骤”是指已接受，并适用于所有订单类型的最小订单增幅量。例如，以UK100这产品为例，最小交易步骤是0.1手。如果客户下指示买卖0.1、0.2和0.3手的订单，本公司将会执行该交易；但如果客户下指示买卖0.11手的订单，那么本公司将不会执行该交易。客户只能以最小订单量或其倍数进行交易。每种工具的最小和最大交易步骤罗列在往后几页的产品规格中。

CONTRACT SIZE

合约价值

PRIMETIME GLOBAL MARKETS PTY LTD utilizes a Lot-based trading system, which means that all PRIMETIME GLOBAL MARKETS PTY LTD products are aggregated into standardized trade sizes. This simplifies trading by allowing clients to trade in *Lot* increments, and it also provides a price for each *Lot* size rather than averaging open and close prices when multiple positions are taken in the same instrument.

PRIMETIME GLOBAL MARKETS PTY LTD采用「手」作为交易数量基准，交易产品会汇合计成一个标准的交易规模，俗称「手」数，以简化交易。意思是在同一工具中同时持有多个头寸(Position)的情况下，相对于提供每个头寸的开盘收盘平均价，本公司为每个「手」数

提供价格，让客户以「手」数为增量单位进行交易。

STANDARD LEVERAGE

标准杠杆

Clients who have been classified as “retail clients” upon establishing a business relationship with PRIMETIME GLOBAL MARKETS PTY LTD shall be granted by default with a leverage of 1:100. Upon registering a trading account with PRIMETIME GLOBAL MARKETS PTY LTD, all clients are asked to answer a series of questions. These questions are in place to determine the client’s experience when it comes to trading. We call this set of questions the “Appropriateness Test”. Once clients have answered the questions within the Appropriateness Test, PRIMETIME GLOBAL MARKETS PTY LTD immediately assess the levels of trading experience. If the result demonstrates a good and sound understanding of trading leveraged products such as Forex, Metals and CFDs, PRIMETIME GLOBAL MARKETS PTY LTD may increase the client’s leverage up to a maximum of 1:400.

客户在最初与本公司建立业务关系时，将会被默认以“零售客户”的分类开始，并提供一比一百倍(1:100)的杠杆率。而客户在注册交易帐户后，需要回答一系列用以厘定客户关于交易经验的问题，这亦称为「适当性测试」。本公司将会根据适当性测试的结果，评估客户的交易经验水平。如测试结果显示客户对外汇，贵金属和差价合约等交易杠杆产品有深入了解的情况下，本公司可以将客户的杠杆率提高到最大的一比四百倍(1: 400)。

MINIMUM MARGIN REQUIREMENTS

Margin requirements differ by the type of instrument and may be subject to change according to the underlying liquidity and volatility of the instrument. PRIMETIME GLOBAL MARKETS PTY LTD Margin Requirement Rates are displayed in the product specification list below.

TRADING HOURS

交易时间

PRIMETIME GLOBAL MARKETS PTY LTD’s trading hours for CFD products are based on when their underlying reference markets are open, or the times liquidity providing partners are streaming prices. During session breaks, clients are able to set pending orders, open and close trades, and to adjust price levels. CFDs will not be opened for trading during holidays in which the reference markets are closed. When the market is closed, clients will not be able to take any actions on positions or pending orders.

SESSION BREAK

中段休市

CFD products have an intraday break in addition to the daily closing time. Clients will not be able to adjust or close existing positions, or open new positions during the session break. All trading functionalities will cease upon the end of week closing.

FINANCE CHARGES – OVERNIGHT ROLLOVER

PRIMETIME GLOBAL MARKETS PTY LTD's daily interest debit or credit amounts (hereafter "rollover") are based on the total face value of the open positions and it will not be debited/credited on a position that is opened and closed on the same trading day. All open positions are rolled automatically to the next trading day. Depending on whether an order is long (buy) or short (sell), it could either be debited or credited with rollover interest on a daily basis. Please note that all open positions in FX and Metal products at the close of business on Wednesday incur a 3-day rollover, whereas clients' positions in CFDs based on Indices, Energies that are open at the close of business on Friday will incur a 3-day rollover. Bank holidays will affect the number of days that a position is rolled forward. Details of rollover rates (swaps) are available in the Trading Platform and on our Website.

Example I :

Account Settlement currency: EUR.

Long(Buy) 0.01 Lot EURUSD; Rollover rate for Long is -7.922 points. The end of day market rate is 1.19097 for EURUSD. Therefore, the Rollover Rate Calculation is as follows:

0.01 * (-7.922) / 1.19097 (conversion to account currency) = -€0.07

多头 (买入) 0.01手EURUSD; 多头 (买入) 展期率为-7.922点; 欧元兑美元的当日收盘价为1.19097。

Example II:

Account Settlement currency: USD .

Short(Sell) 0.2 Lots EURUSD; Rollover rate for Short is 5.3 points.

Therefore, the Rollover Rate Calculation is as follows:

0.2 * 5.3 = EUR€1.06/(in this example EURUSD rate: 1.09) = US\$1.09

Clients who hold open positions in futures contracts on the ‘Expiration’ date will be debited or credited by the price difference from the closed contract to the newly opened contract along with a contract rollover fee.
